This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

## Section 4 - First Aid Measures

---

### General Information:

Immediately flush the contaminated eye(s) with lukewarm, gently flowing water until the particles are removed, while holding the eyelid(s) open. **Accidental release:** This product is sold in small packages, and the accidental release from one of these is not usually a cause for concern. ## Section 7 - Handling and Storage
